### GUIDELINES FOR MANUSCRIPT SUBMISSION

Three (3) copies of the manuscript should be sent to the address below. In a cover letter, the author should state that the manuscript being submitted has not been published, nor is being considered for publication elsewhere. The cover letter should contain all pertinent contact information for the author responsible for correspondence with our editorial offices. Articles longer than 30–35 pages will not be considered.

The manuscript should be double-spaced, on one side of the page only, with margins of one inch on all sides. Please include an abstract of 100 words on a separate page. Use the author-date system of citations in the body of the article and for the bibliography. See a current issue of LAND ECONOMICS for guidance. All notes (footnotes) must be at the end of the manuscript as endnotes. Extensive mathematical material is discouraged and if necessary, it should appear in a separate appendix. Tables and figures must be on separate pages.

It is the policy of LAND ECONOMICS to publish papers *only on the condition* that the data used in the analysis are: (1) clearly and precisely documented; (2) readily available to any researcher for purposes of replication; and (3) sufficiently detailed in the specifics of computations to permit replication. Appearance of an article in LAND ECONOMICS constitutes evidence that authors understand these conditions and will abide by the stated requirements.
